Proxy Voting Arrangements and Form

The ALT AGM on 5/9/2007 will vote on the following resolution from the ALT Central Executive Committee for alterations to the ALT Constitution.

"That all the revisions to the ALT Constitution proposed by the Central Executive and contained in the revised version circulated with the Agenda for the 2007 AGM be approved en bloc."

The Agenda for the AGM has been circulated and can be accessed at http://www.alt.ac.uk/docs/agm_2007_agenda.pdf.

Clause 23 of the current Constitution (http://www.alt.ac.uk/docs/constitution2005.pdf) empowers the AGM to alter the Constitution, with the exception of 4 particular "inviolate" clauses - 1, 3, 11, and 24 (change to which requires the prior consent in writing of the Charity Commissioners) - by a resolution passed by not less than two thirds of the members present and voting, or by proxy at, a general meeting.

Individual members and the representatives of organisational or sponsoring members who cannot attend the AGM are entitled to vote by proxy, by appointing Jane Seale, ALT President to cast a proxy vote on their behalf.

If you wish to vote by proxy, here is what to do.
