The changing role of Becta

The last twelve months has been an exciting and challenging time for Becta, moving from being a government agency that has supported the development and delivery of ICT and e-learning for schools and the learning and skills sector, to an agency that directly supports government in the leadership and co-ordination of the DfES e-strategy "Harnessing Technology". Becta has now moved away from direct delivery of programmes to the sector (such as the ILT champions and Ferl Practitioners programmes). In future Becta will work with the DfES Transformation Directorate to lead the co-ordination, evidential base, strategic advice and direction and (where appropriate) the strategic delivery of the e-strategy.

Design for multimedia mLearning

This article presents two case studies of projects developed for Personal Digital Assistants (PDAs). The research team

were interested to find out if engaging, interactive multimedia resources could be effectively designed for this small but mobile device and whether real 'any time, any place' multimedia learning



experiences could be achieved. The article briefly describes the two projects, feedback from their use, and the issues encountered in designing and developing the resources. It was found that the resulting rich learning experiences offer a number of advantages that only portable, personal devices can offer.

Research Committee Following on from my report in the January 2006 Newsletter we issued a call for expressions of interest to join a new ALT Research Committee, chaired by Professor Robin Mason, from the Open University's Institute of Educational Technology; and we received a strong response. RAE 2008 – ALT makes a difference We were grateful for the opportunity afforded us by Diana Laurillard to collaborate with the Department for Education and Skills (DfES) to ensure that a response was made to the July 2005 "Consultation on RAE Panel Draft Criteria and Working Methods". John Cook, Vice-Chair of the ALT Research Committee, has reviewed the final panel criteria and working methods for Unit of Assessment 45 (Education) – **www.rae.ac.uk/pubs/2006/01/byuoa.asp?uk** and writes: I think we can claim 4 small successes from our submission to the consultation (for UoA 45).

- We suggested: "1.2. The UOA 45 descriptor lacked some structural rigour when compared, for example, with that for Unit of Assessment 23 (Computer Science and Informatics)." Result 1: this paragraph has been reshaped.
- We suggested: "1.3. We welcome the inclusion of 'ICT in education', but this would be expressed more accurately as 'use of ICT in all aspects of education'." Result 2: ICT is now seen as a substantive area whereas before it was grouped in with other 'cross-sectoral issues'.
- We suggested: "1.4. The descriptor should also include; ... under 'Sectors', 'informal learning'." Result 3: Informal learning is now included and regarded as an 'educational system'.
- We suggested (in relation to the submission of learning materials as research outputs): "3.1. Paragraph 20 [now 21] ... The phrase 'Such materials must embody original research and make a contribution to knowledge in its field.' would make the position much clearer." Result 4: the phrase 'must embody original research' has been included.

Membership Services Committee I reported in the January 2006 Newsletter on our plans to merge ALT's Membership and Events Committees to form a new Membership Services Committee. The new committee, which will be co-chaired by John Phelps and Barbara Newland, will hold its first meeting on 3 May. An open call for new members was issued recently and confirmation of the full membership will be reported soon.

CMALT I wrote last month to all members and member organisations concerning an introductory offer we have made to encourage uptake of CMALT our certified membership scheme. Stemming from this ALT is in discussions with a number of organisations that are interested in assessing the value of CMALT by putting staff through it on an employer-funded basis. 

Virtual Clinics: Online places for problembased learning (PBL)

Virtual Clinics were conceived as a mechanism to bring rare or inaccessible but authentic practice based learning opportunities to doctors studying at a distance on the School for Health's MSc/PG Diploma in Sport and Exercise Medicine (SEM) at the University of Bath. This case study reports on the first stage in a larger project to design and develop problem based approaches for learning about professional practice. The aim of this pilot phase is to act as a 'proof of concept' providing insights into designing and managing online problem based learning (PBL) processes for learning about clinical practice.
