

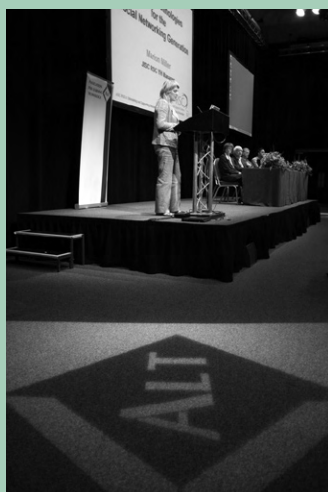

Binoculars and sandpits: a strategy for e-learning

Chief Executive's report

News from Seb Schmoller

Rhonda Riachi: On the final day of the ALT Conference, Rhonda Riachi, ALT Director, announced that she will be leaving ALT at the end of this year, having been employed by ALT since it was founded in 1993. Linda Creanor, incoming ALT President, was able to pay public tribute to Rhonda's outstanding contribution to the development of ALT over the last 14 years. ALT's elected Trustees are now deciding on how to respond to Rhonda's departure. A formal send-off for Rhonda will take place in Oxford during the evening of 8 January 2008, Details will be publicised using the "ALT-ANNOUNCE" Jiscmail list.

CMALT: Teresa Prochazka, ALT Projects Manager moved to a new job at the beginning of September, and we wish her well. One of Teresa's roles was as Certification Manager for our Certified Membership Scheme, CMALT. Until Teresa has been replaced we are grateful to Dr Jay Dempster for agreeing to cover the role on a part-time consultancy basis. Jay's email address is jay.dempster@alt.ac.uk. A new version of the CMALT Prospectus, and revised guidelines for applicants and assessors have been published. Inaugural Learning Technologist of the Year Award: This year we organised the inaugural Learning Technologist of the Year Award, which was presented at the ALT Conference by Dr Peter Norvig, Research Director of Google. The joint winners were Philip Cosson of the School of Health and Social Care at the University of Teesside, and Hannah Whaley, from the Learning Centre at the University of Dundee. The runner up was the PebblePad Development Team from Pebble Learning Ltd, in Wolverhampton. ALT Annual General Meeting: The AGM on 5/9/2007 approved the 2006/2007 Accounts, and the Annual Report, which summarises ALT's activities over the past 12 months. The AGM also unanimously approved some important changes to the ALT Constitution. All three documents are on the ALT web site at www.alt.ac.uk/documents.html. At the AGM, Jane Seale, retiring ALT President presented Terry Mayes, Emeritus Professor at Glasgow Caledonian University, and long-standing member of ALT, with Honorary Life Membership of the Association. The 2008 call for nominations for Honorary Life Membership will be issued next spring.

JISC Learning and Teaching Committee: The JISC Learning and Teaching Committee is "responsible for supporting the learning and teaching community by helping institutions to promote innovation in the use of ICT to benefit learning and teaching, research and the management of institutions". I represent ALT on the committee, alongside Lawrence Hamburg from the HE Academy, Stuart Jones from Becta, and John McLaughlin from the Department of Innovation, Universities and Skills. Representatives on JISC committees are required to report briefly in writing to their organisations: ALT and JISC have agreed that a suitable vehicle for this is through this quarterly column in the extended web-based version of the ALT Newsletter, where key points from the committee's 18 September 2007 can be found.

Introducing e-portfolios across a paper dominated university

The use of an e-portfolio approach to supporting learning across a range of subject areas is described and evaluated. Views of undergraduate students on the effectiveness and value of e-portfolios were sought via a questionnaire and face-to-face interviews. The evaluation addressed student attitudes towards the use of multimedia, considered students' perceptions of the value of making e-portfolios and examined the impact of working electronically on individual development and achievement. The study found that a significant number of students stated that making an e-portfolio helped them to think more about what they had learned and achieved.

Towards maturity in e-learning: Lessons from the e-skills UK research

In 2006 the Skills for Business Network commissioned e-skills UK to conduct some detailed research amongst commercial organisations on the 'ingredients' for successful e-learning. The study of over 200 employers and 1,000 learners allows a comparison between the education sector and commercial sectors to be made. Despite providing more support to learners and placing more emphasis on collaborative learning, overall the Education sector still achieves less business impact than other sectors. There are exceptions, however: this article describes examples where business impact is being delivered by the education sector, for example at Walsall College Hair and Beauty School.

Academics and publishers advance e-learning: a view from the USA

In the USA publishers now provide e-learning materials and online services to academics for use by their students at no cost to the institution. Jim Farmer reports on how the costs of these "supplementary materials" are increasingly included in the rapidly rising price that students pay for textbooks. He argues that this student

financing of course materials has emerged without consideration of the impact it may have on students and faculty. The UK may face a similar situation if our government and institutions fail to find alternative methods of financing authoring and distributing e-learning materials.
