



# Blended Learning Essentials: Accreditation pathways

# Welcome

This is a short guide for course participants interested in accreditation pathways for Blended Learning Essentials Part 1: Getting Started, Part 2: Embedding Practice, and Part 3: Developing Digital Skills.

As a course participant you have a number of ways to gain professional recognition and accreditation for participating in the course and as a next step in your professional development.

Some accreditation pathways are more suited for participants who complete all parts of the course but most options are available to participants regardless of which parts of the course have been completed or in which order.

This guide provides information on the different pathways:

- FutureLearn Certificate of Achievement or Statement of Participation.
- The course is accredited by the CPD Certification Service.
- Accreditation via professional bodies for participants who seek wider recognition of their professional practice;
- Paths to post-graduate qualifications for participants whom the course inspires to further study.



# FutureLearn Certificate of Achievement or Statement of Participation through upgrading

## Summary

By upgrading your FutureLearn course you receive additional benefits, including a [Certificate of Achievement or a Statement of Participation](#) when you become eligible. These documents are available in both digital and printed formats, to help you demonstrate your learning.

## What are the benefits of upgrading Blended Learning Essentials?

*Unlimited access to the BLE course* for as long as it exists on FutureLearn means you can return to the materials at any time to revisit blended learning in your own practice.

To help demonstrate your learning, a *Certificate of Achievement or Statement of Participation* will be sent to you when you become eligible.

*Access to tests:* Where tests are included on a course, validate your learning by accessing this step.

Your Certificate of Achievement or Statement of Participation will give you official evidence, to show to your current or future employer, including:

- an outline of what you've learned and how long it took;
- the logos of the university and other organisations associated with your course;
- and the lead educators' signatures.

The majority of FutureLearners who achieve a Certificate add it to their LinkedIn profile, CV or resumé, or use it as evidence of their participation and validation of test results. Your digital Certificate will be a permanent web page, with a unique address, so you can: add your Certificate or Statement to LinkedIn with one click; share it with friends or employers via social media or email; and include it in your CV or resumé with ease.

# Qualified Teacher Learning and Skills (QTLS)

## Summary

Qualified Teacher Learning and Skills (QTLS) is a professional status that you can gain by successfully completing professional formation.

Professional formation is a post-qualification process that enables you to demonstrate the effective use of skills and knowledge in your professional practice that is required to achieve QTLS status. Professional Formation is underpinned by the [Professional Standards](#) which includes promoting the benefits of technology and supporting learners in its use.

You can register for QTLS from 1 April to 31 May. You would be working towards sending us your completed on-line application by the end of October for review in November and notification of the outcome in December. The next opportunity to register runs from 1 September to 31 October.

## What are the benefits of gaining QTLS status?

- More than 15,000 have achieved QTLS status since its introduction in 2008
- QTLS status is recognised in law as equal to QTS for teaching in schools
- Career progression: QTLS status demonstrates your commitment, skills and knowledge to employers
- Recognition of your status as a professional teacher or trainer
- Valuable continuing professional development (CPD) that builds confidence and enhances your skills
- Members with QTLS can use these initials as a designation.

## Certified Membership (CMALT)

CMALT stands for Certified Membership of the Association for Learning Technology (ALT). Established in 2004, CMALT is one of the longest established accreditation schemes specifically for practitioners seeking recognition for their existing skills and experience in learning technology.

CMALT is portfolio-based and requires each portfolio to cover 4 core areas (including implementation of technology, communication and teaching/training), and also allows participants to choose a specialist option that fits with their particular role, thus providing real flexibility.

In order to provide a clear route to CMALT accreditation for course participants, we have mapped the curriculum of the course to the CMALT framework (see the [website](#) for full info).

### What are the benefits of gaining CMALT?

CMALT is a peer-based professional accreditation scheme developed by the Association to enable people whose work involves learning technology to:

- have their experience and capabilities certified by peers;
- demonstrate that they are taking a committed and serious approach to their professional development.

Once you have CMALT, you receive a full range of benefits including:

- Inclusion on the list of Certified Members;
- Inclusion on the CMALT Consultants Register;
- Option to become a CMALT Assessor;
- Use of CMALT as post-nominal letters;
- Access to members-only discussion list and resources and events discounts.

The CPD Certification Service was established in 1996 as the leading independent CPD accreditation institution operating across industry sectors to complement the CPD policies of professional and academic bodies.

The CPD Certification Service provides support, advice and recognised independent CPD accreditation compatible with global CPD principles.

This course has been certified by the CPD Certification Service as conforming to continuing professional development principles. Participants who complete any or all parts of the course qualify for this, with participants completing part 1, “Getting started” achieving 20 hours, those completing part 2, “Embedding practice” achieving 12 hours of CPD time, and those completing part 3, “Developing Digital Skills”, achieving 8 hours of CPD time.

CPD enables you to adapt positively to changes in work/industry requirements. Planning CPD helps you to be more efficient with time, and recording CPD properly provides evidence of professional development (CPD records can be useful for supervision and appraisal meetings).
